NOTICE OF HEARING AND REQUEST FOR COMMENTS

To: Service List for Case No. 9361 and Interested Persons

On September 25, 2017, pursuant to Merger Condition No. 13 in Maryland Public Service Commission (“Commission”) Order No. 86990, Potomac Electric Power Company (“Pepco” or the “Company”) filed a proposal for a pilot public-purpose microgrid project to provide enhanced energy services in Prince George’s and Montgomery Counties. At that time, the Company indicated that the Counties are continuing to refine certain aspects of the proposal, and Pepco planned to supplement the filing with additional information by February 15, 2018.

On February 15, 2018, Pepco filed its updated microgrid pilot proposal).¹ The updated filing contained the following additional information:

- Updated Prince George’s County and Montgomery County Microgrid Characteristics
- Refined Microgrid Cost Estimates
- Summarized Community Engagement Activities and Stakeholder Feedback
- Revised Microgrid Construction Schedule

The Commission hereby provides notice that it will hold a legislative-style hearing on Tuesday, April 24, 2018, for the purpose of considering the public-purpose microgrid pilot proposal filed by Pepco. The hearing will begin at 10:00 a.m. in the Commission’s 16th Floor Hearing Room, William Donald Schaefer Tower, 6 St. Paul Street, Baltimore, Maryland 21202.

In addition, the Commission requests that written comments on the Proposal be filed by April 6, 2018, from stakeholders and interested parties.
