Pursuant to the "Open Public Meetings Act", N.J.S.A. 10:4-6 et seq., the New Jersey Board of Public Utilities ("Board") hereby gives notice of a Public Meeting to discuss the following item:

In the Matter of the Board's Review of the Retail Margin and the  
Commercial and Industrial Energy Pricing ("CIEP") Threshold  
Docket No. EO10050338

The "legislative-type" hearing in this docket will be held in Trenton on Friday, August 20 from 10:00 to 1:00 in Committee Room 11 in the State House. The purpose of the hearing is to take comments on: 1) whether the Retail Margin the Board imposed on larger customers with a load above 750 kW is still serving its intended purpose, and 2) whether there should be any adjustments to the CIEP threshold. The hearing will be chaired by President Lee Solomon.

For those unfamiliar with the process, interested parties will be allowed a fixed amount of time to present their comments, after which the Commissioner may have some clarifying questions. The amount of time allotted will be determined by the Commissioner at the hearing.

Parties wishing to be heard should e-mail John Garvey at [John.Garvey@bpu.state.nj.us](mailto:John.Garvey@bpu.state.nj.us) by August 13. If you will be working from prepared comments, please email them to Mr. Garvey, and bring at least 15 copies to the hearing.

Final Comments on the Retail margin and CIEP Threshold will be due on Friday, September 3, 2010. Final Comments should only be used to respond to issues raised in the Initial Comments, issues raised at the Legislative-type hearing or questions issued by Board staff as part of this matter. They should not be used to raise new issues in this proceeding.

Final Comments should be filed with the Board's Secretary at Two Gateway Center, Newark, New Jersey 07102, and should also be electronically served via email to parties on the e-service list for this proceeding.
