Pursuant to the "Open Public Meetings Act", N.J.S.A. 10:4-6 *et seq.*, the New Jersey Board of Public Utilities ("Board") hereby gives notice of a Public Meeting to discuss the following item:

In the Matter of the Provision of Basic Generation Service ("BGS")  
for the Period Beginning June 1, 2011 - Docket No. ER10040287

The "legislative-type" hearing in this docket will be held on Tuesday, September 21, 2010 at 10:00 a.m. at the Board's office at Two Gateway Center, Newark, New Jersey, in the 8th floor hearing room. The purpose of the hearing is to take comments on the Electric Distribution Companies' BGS proposals filed on July 1, 2010, as well as on any alternative BGS proposals filed by interested stakeholders. The hearing will be chaired by Commissioner Elizabeth Randall.

For those unfamiliar with the process, interested parties will be allowed a fixed amount of time to present their comments, after which the Commissioner may have some clarifying questions. The amount of time allotted will be determined by the Commissioner at the hearing.

Final Comments on the procurement proposals will be due on Friday, September 24, 2010. Final Comments should only be used to respond to issues raised in the Initial Comments, issues raised at the Legislative-type hearing or questions issued by Board staff as part of this matter. They should not be used to raise new issues in this proceeding.

Final Comments should be filed with the Board's Secretary at Two Gateway Center, Newark, New Jersey 07301, and should also be electronically served via email to parties on the e-service list for this proceeding.
